



The scientific requirements for the doctoral degree set by the PIGTDI

Addendum to Annex 15 to the DCNSIT-DR

1. At least 5 pieces of a least 4-page-long articles in English.
2. At least 250% cumulative authorship in peer-reviewed journal articles of at least 4 pages in English or in articles of at least 4 pages in English published in a WoS/Scopus indexed conference.
3. At least 150% cumulative authorship of WoS impact factor English-language journal articles of at least 4 pages and at least one of which was published outside Hungary.
4. At least a total of 150% cumulative authorship in SJR rated Q2 or above in English articles of at least 4 pages.
5. In the case of Hungarian native speakers, at least 1 journal article, scholarly article or conference paper in Hungarian.
6. At least 1 presentation in English at an international conference.

Only publications that are not objectionable according to the MTMT in the year of publication and that have a minimum of 12.5% of the Candidate Author's share will be considered.

The 4-page limit does not apply to highly ranked scientific journals (e.g. Nature, Science), which tend to publish articles shorter than 4 pages.

Only publications related to the topic of the theses can be taken into account when calculating the authorship. The authorship share is determined by an even distribution between authors, excluding the consultant in the number of authors. Only one of the co-consultants may be considered. The candidate must indicate which of his/her consultants he/she wishes to exclude from all his/her articles. Publications may be partially replaced by equivalent subject-specific works with the agreement of the Doctoral Council.

The professional weight of scientific work presented in the form of oral or poster presentations at international and national conferences varies from case to case, and such publication activity can therefore only be taken into account as an additional criterion.

Deviations from these requirements are possible by unanimous decision of the Doctoral School Council.

In the case of multiple co-authors, the applicant must provide the authors' declarations for the articles (signed by the co-authors). If this is not done, the 100% will be divided by the number of authors.

Outstanding scientific results (if at least 300% of the publication requirements for the degree have been met) may be submitted in the form of a shorter abstract (at least 30 pages) with the prior agreement of the Doctoral School Council.
